## DISCUSSIONS

Administration discussed challenges in tracking the line item transfers on the budget versus actual reporting. There are modules in the ACS software that can be updated but the current server will not support this.

Administrator Robichaud gave an update on the Route 28 Roundabout project (general timeline with Spring 2019 start) and moving County water lines. Disruption in water service is expected to be 24 hours or less when air release valve and a shut off valve are replaced. Project completion expected to be November. Estimated cost to the County is \$30,000. This amount needs to be appropriated in the 2019 County budget.

Siemens Energy Contract financing rate holds until March 18.

Rep. DesMarais suggested the formation of a committee with Coos County to consolidate some of the jail expenses and responsibilities if the Coos County Delegation is interested in exploring the options.
