Approval of Minutes

Work Session

Commissioners reviewed the no-smoking policy and discussed hiring grounds keeper for the summer to do the mowing & weed whacking.

Jason Henry - Medical Policy Review

Jason presented the commissioners with policies for Controlled Medications, Medication Verification, Self- Inflicted Injuries and Inmate Medical Co – Payment for their review and approval.

Commissioner Ahlgren motioned to approve the policy & procedures as presented by Superintendent Henry seconded by Commissioner Babson: all in favor. So voted

Steve Knox – Farm Committee update

Steve reported that Rosalie Wilson attended the last meeting and Jessie Wright is working on the RFP for the feasibility study. Andy Kendall has said he is willing to make a contribution toward the feasibility study.

Chuck Stuart – Agreed Upon Procedures

Chuck reported that the attorney and John Beardsmore agree, the county delegation cannot not force the commissioners to do a forensic audit. Chuck sent out the RFP for a forensic audit and

did not get any responses. Commissioners asked Chuck to follow up with the auditing firms he sent the RFP to, and see if they intend to respond.

Public Input

John Ruckenbrod feels the commissioners already consented to the forensic audit by putting it the budget.

Administrator Updates

Ken reported the county received another 91A request from Seth Hipple, attorney for Ed Comeau wanting information on the Health Insurance from 1998 through 2012.

Ken walked around with Will DeWitte and found there is a lot of old machinery in the barns and one of the barns needs to be repaired or razed.

The farm will be buying salt by the truck load this year, which is much less expensive than the bags.

Howie Chandler & Lori Tetreault

Howie and Lori addressed a letter from Deanna Chaffee that claims MVC is under staffed.

Lori reported this is incorrect information as the state survey did not find any concerns in staffing in the past year. In the last quarter MVC was at the minimum level for 9 days, the rest of the quarter was above the minimum.

<u>Domenic Richardi – Grant discussion</u>

Domenic combined with towns applied and was approved for a grant in the amount of \$26,948.00. This grant is for extra patrols and boot on the ground in known drug areas.
