Commissioner Sorensen motioned to accept Septic Solutions bid in the amount of \$21,200 per year and Stewarts Septic for grease tank pumping in the amount of \$2,400 per year seconded by Commissioner Babson: motion passed on a 2-0 vote

Bob Murray – Generator Contract

Bob informed the commissioners that our current provider Generator Connections has offered another 1 or 2 year contract at the current price. Bob would like to take advantage of this offer.

Commissioner Babson motioned to accept & extend the Generator Connection contract at the current rate for an additional 2 years seconded by Commissioner Sorensen: motion passed on a 2-0 vote.

Commissioner Sorensen motioned to adjourn at 11:25 am seconded by Commissioner Babson: motion passed on 2-0 vote.
