Ken presented the commissioners with a quote from MelansonHeath for the two areas the delegation would like audited.

- 1. Eastern Propane Verify the delivery location of all Eastern Propane deliveries received in calendar year 2017.
- 2. Credit Cards Prepare a detailed analysis of credit card activity for 2017 using invoices/bills/supporting documentation and accounting records provided by county staff. Determine if RSA 30-A:2 has been adhered to. The cost for this is between \$6,500 \$7,500
