Performance Audit

Ken presented the commissioners with the following letter to the delegation:

Dear Chairman,

Please find this letter as a formal request to hold an additional Delegation meeting in December. As you may know, all delegation meetings must be posted 7 day prior to each meeting, the meeting day must be excluded of the 7 days. We have several items that must be taken care of and must be posted properly in order to be lawful. Because the posting of the meeting on the 10th was posted (advertised) only 6 days prior to the meeting, this meeting will not hold to the scrutiny of bond counsel. Therefore; we are requesting another meeting that is posted more than 7 days prior to the meeting, to be on the side of caution.

RSA 24:9:c states; further meetings of the Delegation, the Chairman of the Delegation shall call a meeting upon the written request of the County Commissioners. Joe asked the commissioners to authorize him to speak with banking institutions about TAN's

Commissioner Babson motioned to authorize the Treasurer to speak with any banking institutions about TAN's Seconded by Commissioner Hounsell: all in favor. So voted

Ken presented the commissioners with Line item transfer request #28 for \$800.00 from line # 100.4193.062 to line # 100.4193.075 approval and signatures.

Commissioner Babson motioned to approve transfer request #28 in the amount of \$800.00 seconded by Commissioner Hounsell: all in favor. So voted

Hales Location

Ken presented the commissioners with an invoice from Avitar in the amount of \$730.00 for tax software.

Commissioner Hounsell motioned to approve payment of \$730.00 for tax collecting software for Hales Location seconded by Commissioner Babson:

Commissioner Hounsell motioned to table the motion seconded by Commissioner Babson: all in favor. So voted

Commissioner Babson motioned to pay 2018 Carroll County taxes in the amount of \$94,368.00 for Hales Location seconded by Commissioner Hounsell: all in favor. So voted

Commissioner Babson motioned to sign \$9,000 check from Hales Location for commissioners acting as the governing body for Hales Location in 2018 seconded by Commissioner Babson: all in favor. So voted

Commissioner Hounsell motioned that the commissioners approve payment of check# 2196 for petty cash in the amount of \$26.22 seconded by Commissioner Babson: all in favor. So voted.

Ken informed the commissioners that he received a complaint from a resident that the Hales Location office was not opened for two consecutive Saturdays.

Commissioner Hounsell motioned to authorize payment in the amount of \$1,000 to Kathleen Golding for administrative services Motion failed for lack of second

Commissioner Babson motioned not to pay Kathleen Golding until they find out if the office was closed seconded by Commissioner Bevard: motion passed on a 2-1 vote with Commissioner Hounsell voting "Nay"

Jason Henry - Flooring Project

Jason asked the commissioners to approve flooring project in the amount of \$5,000.00

Commissioner Hounsell motioned to approve hiring Maine Made Custom Builders for a flooring project at the jail in the amount of \$5,000 for the following reasons: they have done work at the jail previously, they can start immediately, not able to get any other bids seconded by Commissioner Babson: all in favor. So voted

Administrator Updates

There was discussion about the Zina Ryan sentencing. Jason was disappointed at the 12 months suspended sentence and for not being notified of the plea deal by the County Attorney's office.

Commissioner Babson motioned to write a letter to the County Attorney regarding the Zina Ryan case.

Ken informed the commissioners that he met with Representative Steve Woodcock.

A claim has been filed with Primex on the generator.

Ken recommended holding off until 2019 for the nurse scheduler software.

Commissioner Babson attended the Ossipee Selectman's meeting about the roundabout at the intersection of route 171 and 28.

Commissioner Bevard reported that the Lands Committee met on Friday and they are working on a survey to go out to local Farms and other businesses.
