Commissioners Update

Commissioner Babson has concerns about the condition of County Farm Road and spoke with the director of public works for the town of Ossipee. Commissioner Babson would like to send a letter to the Ossipee Selectmen letting them know that the road is a hazard and needs to be addressed.

Commissioner Bevard would like to change how the elected officials are paid; she would like them paid monthly.

Commissioner Hounsell motioned that beginning January 2019 for the purpose of elected officials will be paid at the last pay period of each month for 24 months seconded by Commissioner Babson: all in favor. So voted

Commissioners discussed how to answer a letter received from Representative McConkey.

Commissioner Babson motioned to send a letter to Representative McConkey saying "We are in receipt of your letter and we have been and are continuing to work on these issues seconded by Commissioner Hounsell: all in favor. So voted
