Commissioner Bevard called the meeting to order at 8:30am / Pledge

Commissioner Bevard motioned to approve the minutes of September 12, 2018 seconded by Commissioner Babson: all in favor. So voted

Commissioner Babson motioned to approve the minutes of August 22,&29 2018 seconded by Commissioner Hounsell: all in favor. So voted

#### Roller Shelving Bid Award

Commissioner Hounsell motioned to again ratify by signing the CBA MVC and AFSME dated 07/1/218 – 3/31/19 retroactive to 7/1/2018 seconded by Commissioner Babson: all in favor. So voted

Ken presented the commissioners with an RFP for GASB Statement No. 75, which replaces GASB 45. This is an Accounting and financial reporting for post-employment benefits other than pensions.

The commissioners instructed Ken to posit the RFP on the website and put it in the newspaper.

Ken presented the commissioners with a spreadsheet of elected official's salaries for review, prepared by Controller Kathy Armstrong.
