Carroll County Commissioners Meeting May 02, 2018 8:30 am

Present: Commissioners Amanda Bevard, David Babson, Mark Hounsell

Commissioner Bevard called the meeting to order at 8:30 am/Pledge

Commissioner Babson motioned to approve the minutes of April 25th, 2018 seconded by Commissioner Hounsell: all in favor. So voted

<u>Public Input</u> — Daymond said that some people in the county are not eager to get involved in the pharmaceutical law suit.

Jason Henry - Sgt. Corliss - Lt. Baker

Sgt. Corliss has offered to use his GI Bill to pay for a working dog and training. Sgt. Corliss asked the commissioners to pay for one vet bill per year, transportation and lodging to the training. The dog will be used at the jail to detect contraband.

The commissioners asked that Sgt. Corliss write an MOU between county and himself, to be presented to them on May 16th.

Commissioner Hounsell motioned that the training budget to send Sgt. Corliss to San Antonio for K-9 training June $18^{th} - 29^{th}$ seconded by Commissioner Babson: all in favor. So voted

- Lt. Baker discussed the inmate programs with the commissioners. The following are some of the community events with which the inmates helped.

Will DeWitte - Hay Tedder Bids

The following two bids were received:

1. The Bliss Farm Chester VT. \$6,500.00 Esch 18' hay tedder American made in Lancaster Co. PA

2. MB Tractor Tilton NH \$6,518.00 Sitrex 19' hydraulic hay tedder \$7,642.00 Kubota 17'1" hydraulic tedder

The bids will be reviewed by Will and he will bring a recommendation to the commissioners at the May 16th meeting.

Blueberry Field Lease

No bids were received for leasing the blueberry field. Will plans to maintain the field and get it ready to lease out next year.

Water Tank Cleaning

Will presented the commissioners with an agreement with Underwater Solutions Inc. for cleaning of the water tank.

Commissioner Hounsell motioned to approve the agreement with Underwater Solutions Inc. of Mattapoisett MA to inspect and clean the water tank not to exceed \$4,480.00 proposal dated April 10^{th} 2018 seconded by Commissioner Babson: all in favor. So voted

Bob Murray - Laundry Truck

Bob requested that the commissioners waive the bid process for the purpose of buying a used laundry truck.

Commissioner Babson motioned to waive the bidding process to facilitate Bob Murray buying a used laundry truck seconded by Commissioner Hounsell: all in favor. So voted

The reason for waiving the bid process is efficiency of time and resources, to facilitate the process. This is a second hand vehicle and will need to be looked at in person.

Loading Dock

Bob presented the commissioners with a proposal from White Mountain Engineering for loading dock access improvements for approval and signature.

Commissioner Babson motioned to accept the proposal from White Mountain Engineering not to exceed \$2500.00 seconded by Commissioner Hounsell: all in favor. So voted

The reason for not going out to bid is because White Mountain Engineering did all the surveying for MVC and they have all the information needed for the improvement to the loading dock.

Grandfather Clock - MVC

Bob asked the commissioners to use the Dube Fund to buy a Grandfather Clock for MVC. Bob had put this in the budget and it was approved 2-1 (Commissioner Hounsell voting "Nay") by the commissioners. The delegation cut it from the final budget.

Commissioner Bevard motioned to use the Dube Fund to purchase a Grandfather Clock for MVC seconded by Commissioner Babson: motion passed on a 2-1 vote with Commissioner Hounsell voting "Nay"

White Horse

Ken presented the commissions with a request from White Horse for a \$15,000 advance on their funding. This is to help with startup costs for their new office in North Conway.

Commissioner Babson motioned to approve the request from White Horse to advance \$15,000 of their funding and lower the remaining monthly payments seconded by Commissioner Hounsell: all in favor. So voted

<u>Hales Location - School Contract</u>

Ken presented the commissioners with Hales Location School contracts for discussion. Superintendent of schools Commissioners Babson suggested that a comparison between wh

Commissioner Hounsell recused himself from this discussion due to conflict of interest.

Pharmaceutical Company Law Suit

Commissioners discussed the law suit and Ken read the following letter received from Rick Hiland:

Hello Commissioners.

I urge you to not join the class action law suit against the pharmaceutical manufacturers / suppliers. They are not the problem. The only ones that will benefit from this suit are the lawyers and only a feel good move in my opinion.

We need to destroy the root cause of the drug problem and not settle on making excuses or playing the blame game.

You might as well file a class action suit against parents & the breakup of the family for starters of the problems.
