Parking Lot Bids

The commissioners opened the one sealed bid received from GMI Asphalt (\$98,720). The bid amount exceeds the budgeted amount (\$85,000). Bevard asked Murray and Robichaud to return to the next meeting with decision on whether to move forward with the project and, if so, present line item transfers to fund the overage. Murray direct solicited five of the six vendors who submitted a bid previously. Three responded to his request. GMI Asphalt was the only vendor to visit the site.
