Check Manifest

Bevard announced the check manifest week ending November 29 total of \$746,473.39.

NHAC Annual Conference

Carroll County is to host the 2020 conference October 26 to October 28. Robichaud suggested the county work towards providing training opportunities for staff at all levels. Robichaud suggested forming a planning committee. The tentative location is North Conway Grand Hotel.

Water Tower Capital Reserve

Robichaud contacted NH DRA. Under RSA 35:1 the County can establish a reserve fund but 35:7 noted water departments can only establish a capital reserve fund from water and sewer rentals. DRA suggests contacting legal counsel to clarify.

MS Forms and DRA

DRA has changed the MS-46 form due date from April to September and the expenditure column to yearend instead of third quarter. Robichaud said next year the county will need to send out the 45-page budget packet to all towns due to the form change.

Hales Location

K. Golding requesting the commissioners encumber the assessing appropriation for the work to be done in 2020. The commissioners reviewed the proposed total budget of \$574,408. Costello will work with Golding to verify accuracy of the "education tuition" line item. Babson will provide McCarthy and Bevard copies of the Conway School District contracts.

Substance Abuse Reduction Grant - Sheriff Domenic Richardi

Richardi presented a contract for the commissioners to review. The grant is formerly known as Granite Hammer and Granite Shield. The \$15,000 grant runs January to June 2020 and is for use by police agencies across the county as overtime reimbursement.
