McCarthy announced the check manifest week ending December 6 total of \$113,952.73

Hales Location Ambulance Contract

MOTION:

"To sign the Hale's Location ambulance with Conway Village Fire District"

by Babson, 2nd McCarthy. Passed.

MVC Ceiling Lifts - Bob Murray

Murray asked for permission to sole source this purchase (Handicare) using the same vendor as the past eight years. Proprietary lifts and Murray would like to stick with the same brand. Total amount of request is \$11,411. Chandler noted that these lifts provide mechanical support that reduces staff injury. Murray and his staff are certified to service the lifts.

MOTION:

"Purchase 4 lifts from Handicare for a price not exceeding \$11,411. The reason for sole source is MVC currently has 56 units from this company which means we have trained personnel to use the equipment, parts as needed, and there is no reason to have duplicate source needing parts and another company coming in to do repairs" Babson, 2nd McCarthy. Passed.

MVC Tuition Reimbursement

Chandler presented three options for tuition assistance – scholarship, tuition reimbursement, and scholarship loan forgiven in light of continued service (work a year following completion of the course). Chandler will return with further information. No action taken.

Administrator Updates

Robichaud will bring encumbrances for consideration at the December 18 meeting. Examples include jail cameras, dock leveler, auditor contract, etc.

Registry of Deeds Revenue

Robichaud distributed the November 30 revenue report.

Commissioner Updates

Babson asked about the cost of transporting inmates to Wolfeboro (Roads to Recovery) for MAT treatment. The jail doctors are no longer offering medically assisted treatment at the facility, but rather writing referrals to a community doctor. Henry said this is because of the different standards of care approved by the commissioners. The board previously voted to continue MAT for inmates already on a program when entering the jail but not allow induction. Comeau asked if there is a policy relating to inmate transportation and the budgetary impact. Henry said there is a policy and funding in the budget. There may be budgetary impact of the sheriff's budget if that department assists with transport.

McCarthy announced the commissioners received an anonymous letter in support of medication assisted treatment at the jail. Murray was asked to provide the contact information for the medical waste contractor that was not awarded the bid. McCarthy would like the commissioners to write a letter to them giving reasoning for their vote. Robichaud said he has received a right-to-know request from the jail employee's union.
