#### **Check Manifest**

Bevard announced the check manifest week ending November 15 total of \$150,490.90

## White Horse Addiction Center (Mitch Yeaton)

Yeaton reported on the changes made at this agency during the past year.

- Addition of mental health services for adults and juvenile
- Peer to peer emergency support services (emergency call center)
- Implement system of electronic medical records purchased from Echo Group in Conway

The client load to date in 2019 is 235; in 2018, 197; in 2017, 104. Goals in 2020 include opening four recovery houses, 32 beds for men and 20 for women. Currently 20 paid employees and six volunteers. Thrift store is expected to move into a new space and expand. Train the trainer program. Began offering medication assisted treatment as a tool in a full complement of services with case management.

## DPW and Snow Removal - Will DeWitte

Discussion about the challenge of relying on man hours to clear snow from the county complex and the need to mechanize. The executive committee denied the request for line-item transfer to allow for lease of a skid steer. Dewitte gathered more information to answer their questions so hopefully it will be approved at their next meeting.

Jail Update - Jason Henry

Inc of

The roof project over the egress is complete. An inmate destroyed a door. The cost to replace it and the electronics is about \$7,500. Babson noted unanticipated expenses like this are a good reason to have a contingency fund. Henry noted a two-week medication supply for a pre-trial inmate currently housed at the jail is \$40,000. Henry will draft a letter for the commissioners to send to state and federal representatives regarding the burden on the County budget when inmate Medicaid is suspended during their incarceration. Henry asked for a motion to clarify a vote taken at the commissioner's November 13 meeting regarding MAT (medication assisted treatment).

MOTION: "To allow Carroll County House of Corrections to continue administering

the MAT program for those offenders that come to the jail already on a

prescribed program" by Babson, 2nd McCarthy. Passed 3-0.

MOTION: "To allow the jail to induct (start) inmates who meet criteria for medicated

assisted treatment" by Babson, 2nd McCarthy for discussion. Failed 1-2 with

McCarthy and Bevard opposed.

McCarthy asked for a detailed, step-by-step outline of the induction process.

#### Medical Waste Bids - Bob Murray

A third bid was discovered in the business office after last week's meeting. Murray will return next week with a recommendation.

### Scott Egan - Plodzik and Sanderson

The commissioners previously voted to contract with Egan. This meeting was to clarify services to be provided and timeline. Egan said he would help document procedures, responsibilities and workflow, create redundancies, make recommendations to improve processes, and documentation. McCarthy said it is her hope the board would go along with his recommendations on process and cross training. He can make his first visit to County Nov. 26 to begin a preliminary assessment and expects his work to continue through December and into January 2020. Egan asked for copies of the organizational chart, job descriptions for finance staff and copies of all current financial policies. Egan will draft a consultant engagement letter for the commissioner's review.

#### End 68 Hours of Hunger - Eileen Leavitt, Carol Simpson

The program has requested \$8,000 from in the 2020 County budget. Discussion ensued about the program and its service to GWRSD students in Ossipee, Tuftonboro, Wolfeboro and Middleton, providing weekend food backpacks.

#### Carroll County Child Advocacy Center - Elizabeth Kelly-Scott

Kelly-Scott discussed the work of this program to assist law enforcement in the juvenile interview process and tracking of cases through the judicial system. County Attorney Andruzzi and Rep. John MacDonald spoke in support of the Center's 2020 budget request. Kelly-Scott will forward a copy of the monthly operational report to the commissioners.

#### Auditing RFQ

Robichaud sent RFQs to nine firms. Current auditor Melanson Heath was the only firm to respond with a quote. The commissioners took the proposal under review. Robichaud would like to bring an auditor recommendation to the December public budget hearing for Delegation approval.

The HRIS software (\$15,000) is in 100.4102.101 (Payroll-Checkmate).
