Commissioner Bevard called the meeting to order at 8:30 am/ Pledge of Allegiance

Commissioner Babson motioned to approve the minutes of October 18, 2017 seconded by Commissioner Hounsell: all in favor: so voted

Public Input - None

Domenic Richardi - Dispatch Grant

Domenic informed the commissioners that Phase II of the dispatch grant was awarded in the amount of \$600,000. The grant will now be reviewed by the grant review committee.

Jason Henry - RFP Lobby Tiles

Jason presented the commissioner with an RFP to replace the carpet in the lobby with tiles. Jason also informed the commissioners the jail was awarded another IDN grant for \$42,560

Howie Chandler - RFQ Feasibility Study

Howie presented the commissioners an RFQ for professional consultant services to conduct a feasibility study for Affordable Assisted Living for Elders.

Commissioner Hounsell motioned to approve the RFQ for professional consultant services to conduct an Elder Services Feasibility analysis for Carroll County with the contact person being changed from Ken to Howie: Motion fails for lack of a second

Howie asked the commissioners to consider changing the outdated clinical software (Cerner) with a new updated provider (Point Click Care). Making a decision by November 1st will save thousands of dollars.

Commissioners asked Ken to combine all salaries in one line and change the name of the contingency fund line to emergency contingency.

Commissioner Babson motioned to keep commissioners salaries on a separate line seconded by Commissioner Hounsell: motion passed on a 2-0 vote with Commissioner Hounsell abstaining.

Commissioner Babson motioned to put \$25,000 for inmate medical into line# 100.4102.093 seconded by Commissioner Hounsell: all in favor. So voted

Ken presented the commissioners with a representation letter for the chairperson's signature.

Commissioner Babson motioned to approve the representation letter and have Commissioner Bevard sign it: Motion passed on a 2-0 with Commissioner Hounsell abstaining.

Ken informed the commissioners that Ossipee Head Start is interested in leasing space in the annex.

Ken presented the commissioners with Rural Development Graduation Certificate for signatures.

Commissioner Hounsell motioned to authorize Commissioner Bevard to sign the Rural Development Graduation Certificate concerning other credit availability seconded by Commissioner Babson: all in favor. So voted
