NHCF Grant:

The committee continued their discussion of the NH Charitable Foundation grant and the need for a feasibility study. Where/if anywhere do we need to utilize a feasibility study? What research can we do on our own? Do we have the time to dedicate to the research? Should we request the study or should a potential lessee? The consensus was there was not enough time to apply for a grant from NHCF for a feasibility study by the end of March.

The committee discussed leasing out the county's hayfields, the blueberry bush field and the high tunnel. They agreed an inventory and inspection should be taken of the buildings, equipment, high tunnel and fields. The inventory should

Sandy Brocaar made a motion to ask the commissioners if they would be willing to lease for compensation to a private citizen or business entity the hayfields located on the Carroll County Lands. Dale Drew seconded the motion. The motion passed with one member abstaining.

Sandy Brocaar made a motion to ask the commissioners if they would be willing to lease for compensation to a private citizen or business entity the high tunnel plot located on the Carroll County lands. Mark McConkey seconded the motion. After a brief discussion Sandy Brocaar made a motion to add " and a contiguous garden plot". Mark Mcconkey agreed to the amendment and seconded that motion. The amended motion passed with one member abstaining.
