5:30 p.m. Public Hearing – Proposed Use of ARPA Funds – at Annex Building
- November 19 Mail proposed 2022 budget with 3rd Quarter 2021 actuals to all boards of selectmen
Mail budget binders to include proposed 2022 budget with 3rd Quarter 2021 actuals and all supplementary materials provided by non-profits and department heads to all members of the delegation who will be in office “on the date that appropriations are voted” (NH RSA 24:21-a). The Delegation must wait at least 28 days from the mailing date before voting on appropriations (RSA 24:21-a). With this timeline, the Delegation will have from 12/17/21-3/31/22 to adopt the 2022 budget.
- November 24 9:00 a.m. Commissioners Meeting
- November 25 & 26 Offices Closed – Thanksgiving Holiday
- November 29 Delegation Public Hearing on proposed 2022 budget. The public budget hearing must be held no less than 5 and no more than 20 days after the November 19 mailing (RSA 24:23)
