Department Head Report - Sheriff Domenic Richardi

The communications grant was set to end August 31. An extension has been granted to mid-September due to delay because of lack of equipment availability. Ossipee Valley Mutual Aid Association is funding additional work to simulcast the Wakefield area. Substance Abuse Grant application has been submitted. The second cruiser from 2020 is set to be in service August 30. The 2021 budgeted cruisers are set to be built in September. There is one open deputy position and one full-time dispatch position. Superior Court is back to a mask mandate.

Underwood Engineers – Water System Improvement Study

Meeting with the commissioners prior to touring the water system and meeting in more detail with Dir. DeWitte. Comm'r Tessari asked for a ballpark cost of needed improvements as soon as possible to include in
