Underwood Engineering Service Request

Employee Medical Insurance 2022-2023

Comm'r Tessari: The County was faced with an estimated 14% increase in medical insurance premiums so began seeking cost savings alternative that provided same or closely similar coverage. NH Interlocal Trust was able to create an agreeable policy. MVC Union employees can elect to stay with current plan with County funding 80% of premium and employee 20% or go to the new plan. All other full-time County employees eligible to participate in the NH Interlocal Trust medical insurance will move to the new plan at a cost share of 85% County/15% employee. The net savings to the taxpayers is approximately \$100,000. While it seems we are only passing on minimal savings, our employees will be encouraged to be smarter healthcare consumers and can result in future premium savings in the future.

MOTION: "To approve each NH Interlocal Trust group application: MVC Union employees, 30-hour employees, Medicare Eligible Retirees, and all other

County employees" by Comm'r Tessari, 2nd Comm'r Plache. Passed 2-0

Comm'r Plache: The County spends millions of dollars annually on health insurance and we are used to seeing increases every year. This new plan continues the benefits provided under the current plan. Employees will save significantly. Under the nursing home collective bargaining agreement, we cannot require employees to change plans mid-contract term but we are offering the option for all to switch and share in the savings. I'm proud of this accomplishment.

Other

MOTION: "Approve \$90 stipend for the Deputy Treasurer and authorize Comm'r

Plache to sign" by Comm'r Tessari, 2nd Comm'r Plache. Passed 2-0

Comm'r Tessari: We have received the March invoice from White Horse Recovery and description of March activities. They were able to provide services to about 76 County clients in March. We thank White Horse for their continued work to help in the recovery efforts.
