Dan Yule, Marion Claus, and Jim Miller from Institute for Classical Culture/North Star Academy attended and discussed with the Board their need to find suitable space for their proposed new charter school. They expect to have their Charter approved by June. Hillsdale 1776 Curriculum is their sister school with approved charter.

Plans are to start with K-4 education and then expand in the future to K-8. Brief discussion about the Carroll County Courthouse, currently owned by Ossipee Historical Society. The old County nursing home (Annex) is not available to meet their space needs. Chmn. McCarthy offered to connect the group with Executive Councilors.

<u>Underwood Engineering – Status Update; Project Roadmap (Water System)</u>

Prior to the meeting, several documents provided by Underwood Engineers and discussed during this meeting:

- ESR#2 "begin the recommended work associated with the source water evaluation, including an evaluation of source capacity. Also included is preliminary design for replacement of the system hydrants and Old Route 28 water main, and funding assistance. Finally, final design of the improvements at the source (meter/chlorination) building and storage tank are included in this scope."
- ESR#3 Funded with NH Department of Environmental Services planning grant; Includes evaluation and preliminary design associated with source building and storage, meters at Carroll County buildings, and new residential meters and radios.

Project Roadmap Funding Summary

Dir. DeWitte offered that the DPW can do some of the work to offset project costs. He suggested using his selected vendors for hydrants and residential meters. The costs in the projections are fluid and are subject to supply and contractor availability. Billing will include project updates. Tasks will be authorized by DPW before initiated. The board will review the updated ESRs at their next meeting.

Carroll County Farm Day

Catherine DuFault attended to discuss the Commissioners' idea to bring back the tradition of Carroll County Farm Day this year. Chmn. McCarthy will contact DuFault to assist with forming a committee.
