CFO Weekly Report

CFO Cullen is scheduled to speak to the auditor today regarding status of the 2019 audit.

Avenu Update

The board discussed the status of the purchase order and accounts payable modules and the activation of "seats" so department heads and/or their designee can view their department's budgets in "real-time". CFO Cullen disagrees with the department heads having access to the purchase order module but rather the finance office should be the central purchasing department. Chmn. Bevard noted that is not what the County paid for. Coord. Seamans said Avenu has had the modules ready since July, awaiting the go-ahead to provide the training that is included in the contract and to start the use of the modules. Reference was made to the presentation by Avenu at the October 23, 2019 meeting during which the modules and seats were explained. Chmn. Bevard asked that CFO Cullen set up the department head access and the modules implementation and training by the end of the year.

Employee Travel Guidance (Covid)

The board reviewed this guidance as presented by Dir. Heroux but chose to not adopt it as a policy.

Non-Public Session

On a motion by Comm'r Babson, 2nd by Chmn. Bevard and a 3-0 roll call vote, the commissioners voted to enter into nonpublic under NH RSA 91-A:3, II (a) for sessions 3,4, and 5 and under NH RSA 91-A:3, II (c) for sessions 1 and 2.

Chmn. Bevard announced that the 2021 pay increases will be effective April 4, 2021 rather than April 1 as previously announced. The board also gave CFO Cullen permission to correct minor calculation errors/typos found after today's approval of the budget.
