## **Chief Financial Officer**

Chmn. McCarthy announced that the commissioners have contracted with Bonnie Batchelder of Batchelder Associates, PC to serve as Carroll County CFO. Comm'r Plache noted that the County's financial issues date back more than a decade and that this will make a big difference. The latest audit pointed out exactly where the issues are and Ms. Batchelder was hired to correct these issues.

## Registry of Deeds

Reg. Scott presented the End-September revenue reports. The commissioners opened 13 bids received in response to the 11 requests for proposals put out for purchasing IT hardware. Reg. Scott was given the bids to review and the authority to make the purchase decisions without further approval of the Board. All bids were scanned and are available for public review.

Reg. Scott asked for guidance on the 2022 salary lines as she prepares her budget. Another unknown is if the commissioners will allow use of ARPA funds for the records management system or if she should include in her 2022 budget.

There is funding in the line for the NHAC and Primex conferences as well as professional certification costs for Dir. Heroux and the HR Generalist.
