Registry of Deeds

The Registry has ordered the last equipment and Carroll County IT will install it to ensure the office is able to fully operate if the Land Records Management System (LRMS) Vendor is affected by an internet interruption. Year 2 and beyond of webhosting is in the final stages of setup. ARPA funds have been allocated to pay for year one of the LRMS and set up and payment of web hosting for year 2. Year 2 maintenance fee of \$27,500 will be included in the deeds budget for 2023 and beyond as agreed to in the contract with AIT LLC, Year 3 of web hosting will be included in the deeds budget for 2024 and beyond. The Register is very satisfied with the expertise and service provided by AIT LLC. Now that the system is operating, the Register has contacted the Department of Homeland Security to have a cybersecurity audit of the Registry systems performed by CISA (Cybersecurity Infrastructure Security Agency).

Total revenues are down 8% compared to August 2021; County share of revenue down 16%.
