Two Bi-Annual Perimeter Treatments performed to immediate exterior of building during Spring/Summer months priced at \$473 per service, totaling at \$946 for annual Bi-Annual Perimeter Treatment investment. Overall 2020 investment totaling at \$2146.</p> <p>*Wasp service performed, if authorized for separate renewal, once per year priced at \$700 for service.*</p>			
<p><b>Pests Included:</b> We will inspect for, and treat as needed for most insect/arthropods that become pests to your facility that are native to the New England States such as: ants, cockroaches, silverfish, beetles, earwigs, crickets, mice and rats, and bee/wasp nests up to 15 feet from the ground. With your properly screened doors, sound trash management, good cleaning practices, we do our best to help you with houseflies and fruit flies. Other pests may be covered as a courtesy during our regular scheduled services.</p>			
<p><b>Pests Managed for Additional Investment:</b> Bee and wasp nests located higher than 15 feet from the ground, honey bee nests or removal, power treatments required for control of flying pests such as cluster flies, midge flies, bee/wasps; or other heavy pest pressures from the exterior such as heavy spider infestations, crickets, millipedes, clover mites, etc. Termites and wood destroying beetles, blood feeding pests (i.e. mosquitoes, ticks, bedbugs, fleas etc.), pest birds &amp; nuisance wildlife (other than mice &amp; rats) i.e. birds, squirrels, bats, skunks, voles/moles, etc., exotic or non-indigenous pests to the New England states. Commodity infesting pests requiring fumigation or space fogging.</p>			



**Terms and Conditions:** JP Pest Services agrees to perform our prescribed services in a manner that is consistent with State, Local and Federal laws. We intend to minimize pest activity while protecting the environment, by utilizing pesticides only as a last resort. We will do our best to help you stay pest free. We require your cooperation with sanitation, structural and storage items. We promise to bring these items to your attention regularly. Without your assistance, we will not be able to help you keep your facility pest free. We reserve the right to charge additional fees to control pests in unfavorable sanitation, structural or storage conditions. Our payment terms are net 45/18% per annum/1.5% interest per month for late payment. Either party may cancel with 30 days written notice. This agreement is valid for one year from the below signed date, unless otherwise arranged for. Trip Charge- In the event that you do not wish to have regularly scheduled service, there will be a \$75 trip charge. Insect Light Traps: Often, JP Pest Services prescribes the use of insect fly lights (ILT) in your facility. Service fees for these units are included in your monthly service investment. The ILTs are owned and operated by JP Pest Services. If in the event that they are lost, damaged or stolen, there will be a replacement fee of \$275.00. Device Replacement: Replacement of damaged or missing devices will be charged at the current rate card. Property Damage: This agreement does not guarantee against present or future pest damage to the building, or its contents, or provide repairs or compensation.

**Annual Ultra—Violet (UV) Bulb Changes:** To ensure maximum efficacy for capturing flying insects, the insect light traps require annual ultra-violet (UV) bulb changes. JP Pest Services installs only shatterproof bulbs in the insect light traps to maximize your safety. There will be an annual fee of \$12.50 per bulb for replacement.

**Hours of Operation/Emergency Services:** Our service hours are Monday through Friday, 7:30 A.M. to 4:30 P.M. Emergency services for off-hours, weekends and holidays are available at additional charge. Your approval is necessary, via a written quote.
