The committee reviewed the organizational chart, finding eight positions are non-union. Lieutenant has been moved to captain position. Two sergeants have applied for training and transport lieutenant position. Officers will then be promoted to fill vacancies. All positions in the proposed 2021 budget. CFO Cullen provided salary breakdown and personnel narrative prior to the meeting.
6100.008 Nursing Salaries	\$256,769	Overage in line-item overspent in 2020 due to several factors – change in staffing, used agency to fill an extended absence. New director hired
6100.009 Salaries	\$1,357,645	Rep. Cordelli sent list of positions he received in 2019 and asked for clarification on change in staffing. No new positions are requested this year. Union employees receive 4.8% wage increase per union contract – 2.5% April 1 and 2.3% at employee anniversary day and completion of performance evaluation (pass/fail). Supt Bachelder will provide evaluation policy with committee. Rep. Cordelli asked for 2019-2021 comparison of the total of four salary lines. Coord. Seamans provided answer via email during the meeting: .005 Overtime .007 Administrative Salaries .008 Nursing Salaries .009 Salaries – Union 2019 (Actual Spent) \$1,875,995.46 2020 (Actual Spent) \$2,040,037.13 2021 (Proposed) \$2,099,393.00 Difference 2019 to 2021 = \$223,397.54

Of the 51, 17 are boarders (7 for Belknap County, 5 Strafford, 4 Rockingham, and 1 State of NH). Daily rate set annually by the commissioners and varies for each sending facility. Current rates Strafford County \$30/day; State of NH \$56.15/day; Rockingham County \$57.50; Belknap County \$40.00; \$75.00 Federal. Supt Bachelder said when Strafford County receives federal detainees (\$75/day) and needs room in the jail, they send Strafford inmates Carroll County and pay \$30/day per inmate. When Carroll County sends our inmates to another facility we pay the same rate as they would pay if sending an inmate to us. Rep. McConkey asked for a 2019 census detail. Rep. Avellani asked if sending counties are billed for medical services provided in our facility. Supt Bachelder said they are billed for this; that the administrative assistant pays those bills and Carroll County is reimbursed. Supt Bachelder will find out where those reimbursements are posted in the budget. CFO Cullen will assist with answering this question.

Other

Comm'r Plache said Carroll County is taking boarders in at a loss. According to his quick math, the cost is \$140 per inmate per night when the proposed budget is divided by the average daily population of 68 inmates.

Chmn. McConkey asked Supt Bachelder if there is a state or federal mandate on inmate to staff ratio. Supt. Bachelder said there is none. Chmn. McConkey asked Supt. Bachelder what the Jail capacity is, several questions about the how the population is divided and layout of the facility. Supt. Bachelder said he was always told the total capacity at the jail is 131 but it would be "packed like sardines". Sentenced and non-sentenced have to be separated as do men and women. Large percentage are not yet sentenced and awaiting trial. Chmn. McConkey what the population was today compared to last year's average population. Today the jail population is 47 and the budget reflects last year's daily population of 68. Supt. Bachelder said there are four cell blocks, size varies, and one contains a more secure unit. The largest percentage of the inmate population at the jail is pre-trial and awaiting sentencing.

Commission Chairman Avellani asked if the Superintendent could offer any additional saving in his budget the Superintendent said he will review and respond later to the subcommittee.

Following up on the Chairman's request McConkey asked looking out, long term if we stop taking in prisoners from outside our county and reconfigure the interior space could we possibly mothball parts of the facility i.e. a cell block creating a savings in staffing and the operational cost. Batchelder said he cannot see that happening.
